However, a portion of your dues payments MAY be deductible as an "ordinary & necessary" business expense. The NCHBA estimates the non-deductible portion of your 2017 dues –the portion which is allocable to lobbying is 50% or \$35.00 and \$35.00 may be deductible. NAHB has determined that 19% of dues or \$34.58 is not deductible and \$147.42 may be deductible.
